Pursuant to adjournment the House was called to order by Speaker Harris at 11:00 a.m.

Roll call showed 35 members present. Representatives Gara, Guttenberg, Kapsner, Ramras, and Salmon were absent and their presence was noted later.

The invocation was offered by the Chaplain, Representative Gruenberg. Representative Coghill moved and asked unanimous consent that the invocation be spread on the journal. There being no objection, it was so ordered.

A few years ago, when my family and I were traveling on the east coast, we stopped over night in Bennington, Vermont, and we stayed just down the road from the house where Robert Frost lived. And, friends, I would like to read and comment briefly on a poem by Mr. Frost that has made all of the difference in my life.

Two roads diverged in a yellow wood,
And sorry I could not travel both
And be one traveler, long I stood
And looked down one as far as I could
To where it bent in the undergrowth;

Then took the other, as just as fair,
And having perhaps the better claim,
Because it was grassy and wanted wear;
Though as for that the passing there
Had worn them really about the same,

And both that morning equally lay
In leaves no step had trodden black.
Oh, I kept the first for another day!
Yet knowing how way leads on to way,
I doubted if I should ever come back.

I shall be telling this with a sigh
Somewhere ages and ages hence:
Two roads diverged in a wood, and I -
I took the one less traveled by,
And that has made all the difference.

Friends, I think that we probably have all taken the road less traveled to get here. And that choice has made all of the difference in our own lives. We can keep that in mind for ourselves and the state as we continue to make important decisions. It is not always the path most taken or most popular that is the best decision. Sometimes the best path is the one only faintly marked or only announced by a small, still voice deep within. And that is the choice that will make all the difference.

- (G) the defense has been provided a reasonable opportunity to view the recording before the proceeding; and
- (H) the court has had an opportunity to view the recording and determine that it is sufficiently reliable and trustworthy and that the interests of justice are best served by admitting the recording into evidence."
