# **One Hundred Eighteenth Day**

Pursuant to adjournment the House was called to order by Speaker Harris at 4:31 p.m.

Roll call showed 36 members present. Representatives Chenault, Kelly, Meyer, and Moses were absent and their presence was noted later.

The invocation was offered by the Chaplain, Jacob Good, House Page. Representative Dahlstrom moved and asked unanimous consent that the invocation be spread on the journal. There being no objection, it was so ordered.
