#### One Hundred Twenty-first Day

Pursuant to adjournment the House was called to order by Speaker Harris at 12:37 p.m.

Roll call showed 33 members present. Representatives Anderson, Chenault, Croft, Gardner, Kapsner, McGuire, and Ramras were absent and their presence was noted later.

The invocation was offered by the Chaplain, the Reverend George Silides of Holy Trinity Episcopal Church. Representative Gruenberg moved and asked unanimous consent that the invocation be spread on the journal. There being no objection, it was so ordered.

"What actions are most excellent? To gladden the heart of a human being, to feed the hungry, to help the afflicted, to lighten the sorrow of the sorrowful, and to remove the wrongs of the injured."

We acknowledge the temptation to seek only our own good, hear only our own truth, and acknowledge only our own suffering. Help anyone of us who sees wrong to undo it with their hand; and if we cannot, then let us speak against it with our tongue; and if we cannot do this either, then let us abhor it with our heart.

"Could it be," asked one of the students, "when you can see an animal in the distance and tell whether it is a sheep or a dog?" "No," answered the Rabbi. Another asked, "Is it when you can look at a tree in the distance and tell whether it is a fig tree or a peach tree?" "No," answered the Rabbi. "Then what is it?" the pupils demanded. "It is when you can look on the face of any man or woman and see that it is your sister or brother. Because if you cannot see this, it is still night."

"Under the authority of art. II, sec. 9, and art. III, sec. 17, of the Alaska Constitution, and in the public interest, I call the Twenty-Fourth Legislature of the State of Alaska into its second special session at Juneau, Alaska in the legislative chambers on May 10, 2006, at 11:00 a.m. to consider the:

1. subject of statutory changes for the purpose of clarifying or providing additional authority for the development of contract terms under the Alaska Stranded Gas Development Act (AS 43.82);
2. subject of judicial review of challenges to the constitutionality of a law authorizing a contract enacted under AS 43.82.435 or the enforceability of a contract executed under a law authorizing a contract enacted under AS 43.82.435;
3. subject of establishing the state entity responsible for financing, owning, and managing the state's interest in the Alaska North Slope natural gas pipeline project, including provisions regarding indemnifications among entities involved in the management of the construction of the project;
4. subject of establishing a method for providing fiscal certainty for certain Alaska North Slope oil and gas leases not covered by the Alaska Stranded Gas Fiscal Contract;
5. preliminary findings and a determination of the commissioner of Department of Revenue made under AS 43.82.400(a)(1); and

6. provisions of the proposed Alaska Stranded Gas Fiscal Contract submitted to the governor by the commissioner of the Department of Revenue under AS 43.82.400(a)(2).

Insert "**; and providing for an effective date**"

Page 4, following line 2:

Insert new bill sections to read:

"\* **Sec. 3.** AS 28.35 is amended by adding a new section to read:

**Sec. 28.35.161. Driving a motor vehicle with a television, monitor, or similar device operating; unlawful installation of television, monitor, or similar device.** (a) A person commits the crime of driving with a screen operating if

(1) the person is driving the motor vehicle;

(2) the vehicle has, temporarily or permanently installed in the vehicle or using power from the vehicle, a television, video monitor, portable computer, or any other similar means to create a visual display visible to the person while the person is driving the motor vehicle; and

(3) the monitor or visual display is operating while the person is driving.

(b) A person may not install or alter equipment described in (a)(2) of this section that allows the display to be visible to the driver while the vehicle is in motion.

(c) Subsections (a) and (b) of this section do not apply to

(1) portable cellular telephones;

(2) equipment that is displaying only

(A) audio equipment information, functions, and controls;

(B) vehicle information or controls related to speed,



fuel level, battery charge, and other vehicle safety or equipment information;

(C) navigation or global positioning;

(D) maps;

(E) visual information to enhance or supplement the driver's view forward, behind, or to the sides of the motor vehicle for the purpose of maneuvering the vehicle;

(F) vehicle dispatching and response information for motor vehicles providing emergency road service or roadside assistance; or

(G) vehicle dispatching information for passenger transport or freight or package delivery.

(d) Subsections (a) and (b) of this section do not apply to equipment installed in an emergency vehicle. In this subsection, "emergency vehicle" means a police, fire, or emergency medical service vehicle.

(e) It is an affirmative defense to a prosecution under (b) of this section that the equipment installed or altered also includes a device that, when the motor vehicle is being driven, disables the equipment for all uses except those described in (c) of this section.

(f) A person who violates (a) of this section is guilty of

(1) a class A misdemeanor, unless any of the circumstances described in (2) - (4) of this subsection apply;

(2) a class C felony if the person's driving causes physical injury to another person;

(3) a class B felony if the person's driving causes serious physical injury to another person;

(4) a class A felony if the person's driving causes the death of another person.

(g) A person who violates (b) of this section is guilty of a class A misdemeanor.

\* **Sec. 4.** Section 3 of this Act takes effect September 1, 2006."

Representative Gruenberg moved and asked unanimous consent that Amendment No. 3 be adopted.

There was objection.

Representative Gruenberg moved and asked unanimous consent to withdraw Amendment No. 3. There being no objection, it was so ordered.

There are two potential courses of corrective action:

1. Produce a corrected version of the bill, explain the problem on the floor, waive the 24-hour rule, and vote on the corrected version.
2. Adopt version N as printed and correct the error in engrossment. Because both House Chief Clerk and Senate Secretary will have the corrected version of the bill, the engrossment process will not be delayed.



Option 2 is the more expedient and is the option I recommend.

A fiscal note submitted by the Department of Corrections clearly makes a fund source change. The note was adopted by the Conference Committee and shows in section 2 of the bill (as a net zero), but the program that generates the fund roll-up in section 3 suppressed printing because the fiscal note nets zero. The programming error has been fixed.

Section 3 makes no appropriations, so is often considered "informational only." Nevertheless, correction of this manifest error would eliminate concerns that the fiscal notes do not match the enacted version of the bill."
