**First Day**

Pursuant to adjournment the Senate was called to order by President Stevens at 11:06 a.m.

The roll showed twenty members present.

The prayer was offered by the Chaplain, Reverend George Silides of the Holy Trinity Episcopal Church. Senator Hoffman moved and asked unanimous consent that the prayer be spread. Without objection, it was so ordered.

With deepest respect for the religious beliefs of all Alaskans, I invite you into a time of prayer and reflection. Let us pray.

O God, the Creator and preserver of all life, we give You thanks for this new day, and for the hopes and dreams and opportunities for great good which make it so very precious to us all.
