DAVID TEAL, DIRECTOR, LEGISLATIVE FINANCE DIVISION, discussed the Item 3. He noted that Representative Holms argued that public television does not need the support it once did with the addition of other educational programs. He did not know the impact.

Representative Croft spoke in support of the higher (Senate) funding level. He emphasized the quality of public broadcasting.

Senator Wilken WITHDREW his motion on Item 3.

The money is set aside in case of environmental problems within Alaskan waters. There is a little over \$700 thousand in the Fund. He maintained that the Fund would not be negatively affected by the use to promote cruise ship tourism in Alaska.

Senator Green emphasized that the fund source would stay the same in future years.

There being NO OBJECTION, it was so ordered.

Senator Wilken MOVED to ADOPT House numbers for Item 13.
