10 but may, when circumstances warrant an exception or when the information
11 is required of a candidate for election to municipal elective office, [SHALL]
12 accept any information required under this chapter that is typed in clear and legible
13 black typeface or hand-printed in dark ink on paper in a format approved by the
14 commission or on forms provided by the commission and that is filed with the
15 commission. Candidates for election to municipal elective office must submit
16 information required under this chapter electronically or in the typed or
17 hand-printed form described in this subsection. In this subsection,
18 "municipal elective office" means the office of an elected borough or city

1 mayor, elected member of a city or borough planning commission, elected
2 utility board member, or elected member of a borough assembly, city council,
3 or school board.”

13 section that is typed in clear and legible black typeface or hand-printed in dark ink
14 on paper in a format approved by the commission or on forms provided by the
15 commission and that is filed with the commission.”

16 “Sec. 4. AS 39.50.050(a) is amended to read:

17 (a) The Alaska Public Offices Commission created under AS 15.13.020(a)
18 shall administer the provisions of this chapter. The commission shall prepare and
19 keep available for distribution standardized forms on which the reports required by
20 this chapter shall be filed. The commission shall print the forms provided under
21 this section so that the front and back of each page have the same orientation when
22 the page is rotated on the vertical axis of the page. The commission **shall require**
23 **[MAY REQUEST]** that the information required under this chapter, **unless it is**

1 information required of a municipal officer, be submitted electronically but
2 may, when circumstances warrant an exception or when the information is
3 required of a municipal officer, [SHALL] accept any information required under
4 this chapter that is typed in clear and legible black typeface or hand-printed in dark
