6 **\*\* Sec. 2.** AS 39.50.030(b) is amended to read:

7 (b) Each statement filed by a public official or candidate under this chapter  
8 must include the following:

9 (1) **for** [THE SOURCE OF] all income over **\$1,000** [\$5,000] during  
10 the preceding calendar year, including taxable and nontaxable capital gains, **and each**  
11 **gift with a value exceeding \$250**, received by the person, the person's spouse or  
12 domestic partner, or the person's dependent child,

13 **(A) the source of the income or gift;**

14 **(B) the recipient of the income or gift;**

15 **(C) the amount of the income or value of the gift;**

16 **(D) the approximate number of hours of services**  
17 **performed to earn the income; and**

18 **(E) a detailed description of the nature of the services**

1            **performed** [EXCEPT THAT A SOURCE OF INCOME THAT IS A GIFT  
2            MUST BE INCLUDED IF THE VALUE OF THE GIFT EXCEEDS \$250];

3            (2) the identity, by name and address, of each business in which the  
4            person, the person's spouse or domestic partner, or the person's dependent child has  
5            an interest or was a stockholder, owner, officer, director, partner, proprietor, or  
6            employee during the preceding calendar year, except that an interest of less than  
7            **\$1,000** [\$5,000] in the stock of a publicly traded corporation need not be included;

8            (3) the identity and nature of each interest in real property, including  
9            an option to buy, owned at any time during the preceding calendar year by the person,  
10           the person's spouse or domestic partner, or the person's dependent child;

11           (4) the identity of each trust or other fiduciary relation in which the  
12           person, the person's spouse or domestic partner, or the person's dependent child held a  
13           beneficial interest exceeding **\$1,000** [\$5,000] during the preceding calendar year, a  
14           description and identification of the property contained in each trust or relation, and  
15           the nature and extent of the beneficial interest in it;

16           (5) any loan or loan guarantee of more than **\$1,000** [\$5,000] made to  
17           the person, the person's spouse or domestic partner, or the person's dependent child,  
18           and the identity of the maker of the loan or loan guarantor and the identity of each  
19           creditor to whom the person, the person's spouse or domestic partner, or the person's  
20           dependent child owed more than **\$1,000** [\$5,000]; this paragraph requires disclosure of  
21           a loan, loan guarantee, or indebtedness only if the loan or guarantee was made, or the  
22           indebtedness incurred, during the preceding calendar year, or if the amount still owing  
23           on the loan, loan guarantee, or indebtedness was more than **\$1,000** [\$5,000] at any

1 time during the preceding calendar year;

2 (6) a list of all contracts and offers to contract with the state or an  
3 instrumentality of the state during the preceding calendar year held, bid, or offered by  
4 the person, the person's spouse or domestic partner, or the person's dependent child, a  
5 partnership or professional corporation of which the person is a member, or a  
6 corporation in which the person or the person's spouse, domestic partner, or dependent  
7 children, or a combination of them, hold a controlling interest; and

8 (7) a list of all mineral, timber, oil, or any other natural resource lease  
9 held, or lease offer made, during the preceding calendar year by the person, the  
10 person's spouse or domestic partner, or the person's dependent child, a partnership or  
11 professional corporation of which the person is a member, or a corporation in which  
12 the person or the person's spouse or domestic partner or dependent children, or a  
13 combination of them, holds a controlling interest.”
