ANALYSIS: *(Attach a separate page if necessary)*
 This bill will convert the class A misdemeanor crime of assault in fourth degree into a class C felony for criminal defendants previously convicted of two misdemeanor assaults or other crimes in violation of AS 11.41.100 - 11.41.289 within 10 years. This bill will also expand the definition of resisting arrest to include resisting arrest by disobeying an order of a peace officer. Additionally, this bill will expand the court's authority to issue search warrants by phone, and the bill sets out additional procedures to be followed when a criminal defendant is incompetent to stand trial. The bill also eliminates the ten day requirement for execution and return of search warrants. Because this bill will create a new felony offense and because it expands the definition of resisting arrest, it will have a fiscal impact on OPA. Unfortunately, it is not possible to reliably predict what this impact will be. Therefore, the agency submits an indeterminate fiscal note.
