First Day

Pursuant to the provisions of the Constitution of the State of Alaska, the Uniform Rules of the Alaska State Legislature, and AS 24.05.160, the House of Representatives of the State of Alaska assembled in the House Chamber for the first regular session of the Twenty-fifth Alaska State Legislature, January 16, 2007, at 11:08 a.m., and was called to order by the Honorable Sean Parnell, Lieutenant Governor.

The Alaska Youth Choir sang "Alaska's Flag" under the direction of Missouri Smyth.
