# **Forty-second Day**

Pursuant to adjournment the House was called to order by Speaker Harris at 11:08 a.m.

Roll call showed 37 members present. Representative Nelson had been excused from a call of the House today.

Representative Samuels moved and asked unanimous consent that Representative Olson be excused from a call of the House from 11:00 a.m. to 6:00 p.m., today. There being no objection, it was so ordered.

Representative Samuels moved and asked unanimous consent that Representative Coghill's excused absence (page 294) be extended to afternoon plane time, today. There being no objection, it was so ordered.
