Pursuant to adjournment the House was called to order by Speaker Harris at 10:08 a.m.

Roll call showed 31 members present. Representatives Crawford, Foster, Johansen, Neuman, Olson, and Roses had been excused from a call of the House today. Representative Chenault was absent and his presence was noted later. Representatives Hawker and Kelly were absent.
