CHAIR SAMUELS announced that the final order of business would be to take up the Longevity Policy Change.

PAT DAVIDSON, Legislative Auditor, Division of Legislative Audit, Alaska State Legislature, stated that with the passage of HB 417, public employees' salary and pay increments for longevity in state service were changed. She explained that committee members had before them two motions. The first motion is in reference to pay increments for committee staff, which she noted are referred to as "partisan staff." However, she highlighted that this policy change would refer to legislative staff such as the staff to the Legislative Budget and Audit Committee, Ms. Sutton. The second motion refers to longevity policy related to employees of the two divisions, Legislative Audit and Legislative Finance.

CHAIR SAMUELS noted that the second motion would be taken up first.
