This bill allows the Dept. of Admin (DOA) to create regulations and develop, implement and maintain policies about electronic information on behalf of each agency; will direct each agency how to secure department data, and coordinate that effort between all the departments. As more regulations and policies are required, there will be a resulting indeterminate financial and personal servcies increase. We expect DOA will charge back departments for oversight and administration of the coordination between agencies, and EED will see an increase in technical and administrative tasks to accommodate this regulatory proposal. Additionally, with the Commissioner of Administration fulfilling the role of Enterprise CIO, each agency head will lose the critical and important responsibility for department data storage, security, and protocols .
