SB 277 would exempt the owners of renewable energy generation facilities from regulation by the Regulatory Commission of Alaska (RCA). The exempted entity would not be subject to RCA certification requirements or RCA regulation of rates and standards of service.

Since the RCA will not be required to certificate or regulate the owners of renewable energy generation facilities, the agency will not experience any increase in workload due to the passage of SB 277.
