CHAIR MEYER announced that the only order of business would be the consideration of two RPLs.

MICHELLE RIZK, Associate Vice President, Budget, Statewide Planning & Budget, University of Alaska (UAF), testified about the two RPLs which were in front of the committee. She explained that RPL 45-0-1141 was a capital fund request of \$7,860,300 for two projects. She described that one project was for the restricted diet and adenosine receptor activation in the amount of \$435,300 and the second project was for enhancing translational biomedical research in Alaska in the amount of \$7,425,000. She explained that RPL 45-0-1142 was an operating fund request for federal Pell Grants for \$3,802,505. She reported that this was the actual amount received to date.
