Senators Stedman and Huggins arrived as the meeting was in progress.

CONTRACTS- STEVEN PORTER

CHAIR MEYER announced that the next order of business would be discussion regarding the contract for Steven Porter.

CHAIR MEYER referred to the current Oil and Gas contract with Mr. Porter and reported that this would be a separate contract for work reviewing the federal stimulus package.

REPRESENTATIVE DAHLSTROM moved and asked for unanimous consent that the committee authorize the chair to engage in a contract with Mr. Porter not to exceed \$100,000.

SENATOR STEDMAN objected for discussion. He asked about the dollar amount and the time element for these services.

CHAIR MEYER explained that Mr. Porter was an attorney and that he was uniquely qualified to help review the federal stimulus package. He noted that the next 45 days were the most critical. He added that Larry Persily, along with Karen Rehfeld, was also examining the federal stimulus package.

SENATOR STEDMAN asked for clarification of the \$100,000 contract for 45 days, and he asked how this new contract would be intertwined with the oil and gas work contract.

CHAIR MEYER offered his belief that the oil and gas contract had also been extended.

JOSH APPLEBEE, Staff to Senator Kevin Meyer, Alaska State Legislature, said that the oil and gas contract for Mr. Porter was extended through the end of this fiscal year, and that the balance for that contract was about \$30,000.

SENATOR STEDMAN asked if Mr. Porter would be working full time on the fiscal stimulus package review for the next 45 days.

CHAIR MEYER, in response to Senator Stedman, said that Mr. Porter's services could be necessary for anywhere between a week and April 3.

MR. APPLEBEE, in response to Chair Meyer, explained that it was unclear if it was allowable for the legislature to move beyond the numerous deadlines in the stimulus. He pointed out that it was also unclear if the legislature would be allowed additional time to act should the governor not take any action.

CHAIR MEYER replied that the intent was to have Mr. Porter available in Alaska to any [legislators]. He mentioned that Mr. Porter would provide weekly updates, at the least. He also noted that Mr. Porter would be working with Representative Hawker's office, and Karen Rehfeld, Director for the Office of Management & Budget. In response to Senator Stedman, he said that his office would coordinate scheduling for Mr. Porter.

SENATOR STEDMAN removed his objection.

CHAIR MEYER asked him to maintain the objection in order to continue the discussion.

SENATOR MENARD asked to clarify that \$30,000 was still available on Mr. Porter's contract through the current fiscal year, and that \$70,000 would be used for review of the federal stimulus package.

MR. APPLEBEE, in response to Senator Menard, said that the balance for the previous contract was about \$30,000. He clarified that this motion was for an additional \$100,000 contract to review the legislature's role within the federal stimulus package.
