**FOR AN ACT ENTITLED**

2 **the termination dates of the Board of Nursing, the Board of Dental Examiners, the**  
3 **Board of Barbers and Hairdressers, the Big Game Commercial Services Board, the**  
4 **Alcoholic Beverage Control Board, and the Alaska Seismic Hazards Safety Commission;**  
5 **and providing for an effective date."**
