Analysis

SB200 amends AS 12.50 by adding new sections governing eyewitness identification. This bill outlines procedures that police must follow when conducting lineups. These procedures include requiring police to obtain and record eyewitness statements, in their own words, that detail specific information about their observations prior to being shown a lineup. This bill also requires, whenever practical, the lineup be conducted by an administrator who is not directly participating in the investigation and is unaware of the suspect's identity in the lineup.

This legislation will have no fiscal impact on the Office of Public Advocacy. The Agency therefore, submits a zero impact fiscal note.
