Pursuant to adjournment the House was called to order by Speaker Chenault at 10:35 a.m.

Roll call showed 36 members present. Representatives Cissna and Neuman had been excused from a call of the House today. Representatives Edgmon and Stoltze were absent and their presence was noted later.

The invocation was offered by the Chaplain, Becca Braun of Congregation Sukkat Shalom. Representative P. Wilson moved and asked unanimous consent that the invocation be spread on the journal. There being no objection, it was so ordered.

With deepest respect for the beliefs and traditions of all Alaskans, I invite you to join me in reflection.

the courage to question your own convictions, the forbearance to listen more than you speak, the humility to ask, "Is there another way of looking at this?"

I would like to close with the *Shehecheyanu*, a Jewish prayer expressing gratitude for the gift of life. It is customarily said on special occasions such as births and weddings, Jewish holidays, prior to eating a fruit one has not tasted before, or upon seeing a friend one has not seen for the past 30 days. Amidst the clamor and tumult of politics, may we remain grateful for the simple gift of our ongoing existence, and may we view each day as an occasion for gratitude.

Baruch atah, Adonai Eloheinu, Melech haolam, shehecheyanu v'kiy'manu v'higianu laz'man hazeh.

Blessed art thou, ruling spirit of the universe, who has given us life, sustained us, and enabled us to reach this day. Amen.
