"* **Sec. 2.** The uncodified law of the State of Alaska is amended by adding a new section to read:

AUTISM TASK FORCE. (a) The Comprehensive Autism Early Diagnosis and Treatment Task Force is created in the legislative branch for the purpose of making recommendations for the development of a statewide comprehensive plan to support early diagnosis and treatment of autism and studying the effects of the state's providing insurance coverage for autism spectrum disorder.

(b) The task force consists of nine members who, except for those in (1) and (2) of this subsection, shall be appointed jointly by the President of the Senate and the Speaker of the House of Representatives as follows:

(1) one senator selected by the President of the Senate, who shall serve as co-chair;

(2) one representative selected by the Speaker of the House of Representatives, who shall serve as co-chair;

(3) one member representing mental health service providers;

(4) one member from the Governor's Council on Disabilities;

(5) the commissioner of health and social services or the commissioner's designee;

(6) the commissioner of administration or the commissioner's designee;

(7) the director of the division of insurance, Department of Commerce, Community, and Economic Development, or the director's designee;
