- (8) has procured, sold, prescribed, or dispensed drugs in violation of a law regardless of whether there has been a criminal action.
- * **Sec. 4.** AS 08.45.200(3) is amended to read:
 - (3) "naturopathy" means the use of hydrotherapy, <u>a dietetic remedy</u> [DIETETICS], <u>an herbal remedy</u>, a <u>homeopathic remedy</u>, electrotherapy, sanitation, suggestion, mechanical and manual manipulation for the stimulation of physiological and psychological action to establish a normal condition of mind and body [; IN THIS PARAGRAPH, "DIETETICS" INCLUDES HERBAL AND HOMEOPATHIC REMEDIES].
- * Sec. 5. AS 08.45.200 is amended by adding new paragraphs to read:
 - (4) "dietetic remedy" means nutritional therapy, nutritional counseling, a nutritional substance, vitamins, or minerals used to promote health and to diagnose, treat, or prevent disease, illness, or conditions;
 - (5) "herbal remedy" means a substance derived from or a concentrate or extract of a plant, tree, root, moss, or fungus;
 - (6) "homeopathic remedy" means a remedy defined in the current version of Homeopathic Pharmacopoeia of the United States;
 - (7) "hydrotherapy" means the application of water to the external body in all forms and temperatures to promote health and to diagnose, treat, and prevent disease, illness, and conditions;
