 3 **engaged in collection of telephone records or electronic data.** (a) A municipality or
 4 an officer, employee, or agent of a municipality may not

5 (1) assist, cooperate with, or participate with a federal agency in the
 6 collection of

7 (A) electronic data under a federal statute, regulation, rule, or
 8 order when the collection of electronic data is undertaken without a search
 9 warrant that particularly describes the person, place, and thing to be searched
 10 or seized; or

11 (B) telephone records under a federal statute, regulation, rule,
 12 or order when the collection of the telephone records is undertaken without a
 13 search warrant that particularly describes the person, place, and thing to be
 14 searched or seized, or in another manner that is inconsistent with state law; or

15 (2) use, in a criminal investigation or prosecution, records or data that
 16 are provided by a federal agency or an officer or employee of a federal agency that
 17 were collected by the federal agency without a search warrant or in another manner
 18 inconsistent with state law as described in (1) of this subsection.

29 (a) A state or municipal agency may not use or authorize the use of an asset to
 30 implement or aid in

31 (1) the implementation of a requirement of

1 **(A)** [(1)] an order of the President of the United States, a
 2 federal regulation, or a law enacted by the United States Congress that is
 3 applied to

4 **(i)** [(A)] infringe on a person's right, under the Second
 5 Amendment to the Constitution of the United States, to keep and bear
 6 arms;

7 **(ii)** [(B)] deny a person a right to due process, or a
 8 protection of due process, that would otherwise be available to the
 9 person under the Constitution of the State of Alaska or the Constitution
 10 of the United States; or

11 **(B)** [(2)] P.L. 109-13, Division B (REAL ID Act of 2005);

12 **(2) the collection by a federal agency of electronic data without a**
 13 **search warrant; in this paragraph, "electronic data" includes electronic mail and**
 14 **text messages; or**

15 **(3) the collection by a federal agency of telephone records without**
 16 **a search warrant, unless the records are collected in a manner consistent with**
 17 **state law.**

19 **Sec. 44.99.050. Prohibition against cooperation with federal agencies**
 20 **engaged in collection of telephone records or electronic data.** (a) A state agency or
 21 an officer, employee, or agent of a state agency may not

22 (1) assist, cooperate with, or participate with a federal agency in the
 23 collection of

24 (A) electronic data under a federal statute, regulation, rule, or
 25 order when the collection of electronic data is undertaken without a search
 26 warrant that particularly describes the person, place, and thing to be searched
 27 or seized; or

28 (B) telephone records under a federal statute, regulation, rule,
 29 or order when the collection of the telephone records is undertaken without a
 30 search warrant that particularly describes the person, place, and thing to be
 31 searched or seized, or in another manner that is inconsistent with state law; or

1 (2) use, in a criminal investigation or prosecution, records or data that
2 are provided by a federal agency or an officer or employee of a federal agency that
3 were collected by the federal agency without a search warrant or in another manner
4 inconsistent with state law as described in (1) of this subsection.
