**BILL NO. SCS CSHB 71(FIN)**

**Analysis**

House Bill 71 extends existing law authorizing the Commercial Fisheries Entry Commission (CFEC) to maintain a vessel-based limited entry system for the weathervane scallop and Bering Sea hair crab fisheries and puts into place a reporting requirement for CFEC to report on their system every two years. Passage of this legislation will have no fiscal impact on the Division of Commercial Fisheries.
