Forty-second Day

Pursuant to adjournment the House was called to order by Speaker Chenault at 10:31 a.m.

Roll call showed 28 members present. Representatives Drummond, Feige, Herron, and Saddler had been excused from a call of the House today. Representatives Edgmon, Guttenberg, Kreiss-Tomkins, LeDoux, Millett, Munoz, and Stoltze were absent and their presence was noted later.
