## Fifty-third Day

Pursuant to adjournment the House was called to order by Speaker Chenault at 10:33 a.m.

Roll call showed 34 members present. Representative Drummond had been excused from a call of the House today. Representatives Hawker, Herron, Kawasaki, Stoltze, and Tarr were absent and their presence was noted later.

The invocation was offered by the Chaplain, the Reverend Dr. Douglas Dye of Chapel by the Lake Presbyterian Church. Representative P. Wilson moved and asked unanimous consent that the invocation be spread on the journal. There being no objection, it was so ordered.

- (E) are not related to each other to a degree of closeness that would preclude them from marrying each other in this state if they were of the opposite sex;
  - (F) are not legally married to another person;
- (G) have not executed an affidavit affirming same-sex partner status with another person within the last 12 months;
- (H) are each other's sole domestic partner and each is responsible for the welfare of the other; and
- (I) share financial obligations, including joint responsibility for basic living expenses and health care costs;"
