An "Explanation to Disclosure" submitted to the Select Committee on Legislative Ethics via email by Ms. Sawyer on February 15, 2013, follows:

"I was involved with SIOA-AK briefly from approximately June 2011 to September 2011. SIOA was a blog site, owned by Pamela Geller of New York. David Heckert was a supporter of SIOA, and when he moved to AK after retiring from the Army, he wanted to start a similar blog. After Pamela testified on behalf of HB 88 in 2011, David called her to discuss making presentations in AK to support the same bill. She allowed him to start an offshoot of her SIOA blog to add credibility to his presentations and to start an Alaska blog. She also made up a title for him.

When I returned to AK, I told David that I was stepping away from HB 88 and all SIOA-AK involvement.

I was never involved with his blog-site and didn't even know it was up. David later said he had asked a couple of supporters to build the blog for him. He said some young people who were related to one of the supporters were the ones who created it. I did not get details. In September 2011, I found out from one of the supporters that my name was on his blog. I was shocked and asked him to remove it. That was the last time I spoke to him. I later found out in December 2011 from an Anchorage supporter that David had left Alaska and moved to Hungary. That was the end of SIOA-AK.

He obviously did not contact any of his Mat-Su supporters that he was leaving AK, nor did he contact the blog creators to close it down, so that is the only reason my name could still be on the site. We all know that just because something is on a web or blog site, does not make it the truth. Sites are abandoned or not kept up all the time.

My voluntary non-board involvement was ONLY from June 2011 to September 2011.
