7 **\*\* Sec. 27. SALARY AND BENEFIT ADJUSTMENTS.** (a) The sum of \$56,985,300 is  
8 appropriated, for the fiscal year ending June 30, 2016, to the office of management and  
9 budget to distribute as provided in (b) and (c) of this section to the appropriate agencies as  
10 provided in those subsections consistent with and in the amounts and from the fund sources  
11 identified in Amendment No. 7B to SCS CSHB 72(FIN), Draft Version "S," that was passed  
12 by the Senate Finance Committee, which removed this sum from the appropriations made in  
13 sec. 1 of this Act.

14 (b) The operating budget appropriations made in (a) of this section include amounts  
15 for salary and benefit adjustments for public officials, officers, and employees of the  
16 executive branch, Alaska Court System employees, employees of the legislature, and  
17 legislators and to implement the terms for the fiscal year ending June 30, 2016, of the  
18 following collective bargaining agreements:

19 (1) Alaska Correctional Officers Association, representing the correctional  
20 officers unit;

21 (2) Confidential Employees Association, for the confidential unit;

22 (3) Alaska Public Employees Association, for the supervisory unit;

23 (4) Alaska State Employees Association, for the general government unit;

1 (5) Public Safety Employees Association;

2 (6) Alaska Vocational Technical Center Teachers' Association;

3 (7) Inlandboatmen's Union of the Pacific, Alaska Region, for the unlicensed  
4 marine unit;

5 (8) International Organization of Masters, Mates, and Pilots, for the masters,  
6 mates, and pilots unit;

7 (9) Marine Engineers' Beneficial Association, representing licensed engineers  
8 employed by the Alaska marine highway system.

9 (c) The operating budget appropriations made to the University of Alaska in (a) of this  
10 section include amounts for salary and benefit adjustments for the fiscal year ending June 30,  
11 2016, for university employees who are not members of a collective bargaining unit and to  
12 implement the terms for the fiscal year ending June 30, 2016, of the following collective  
13 bargaining agreements:

14 (1) Fairbanks Firefighters Union, IAFF Local 1324;

15 (2) United Academics - American Association of University Professors,  
16 American Federation of Teachers;

17 (3) United Academic - Adjuncts - American Association of University  
18 Professors, American Federation of Teachers;

19 (4) Alaska Higher Education Crafts and Trades Employees, Local 6070;

20 (5) University of Alaska Federation of Teachers (UAFT).

21 (d) If a collective bargaining agreement listed in (b) of this section is not ratified by  
22 the membership of the respective collective bargaining unit, the appropriations made in this  
23 section applicable to the collective bargaining unit's agreement are reduced proportionately by  
24 the amount for the collective bargaining agreement, and the corresponding funding source  
25 amounts are reduced accordingly.

26 (e) If a collective bargaining agreement listed in (c) of this section is not ratified by the  
27 membership of the respective collective bargaining unit and approved by the Board of  
28 Regents of the University of Alaska, the appropriations made in this section applicable to the  
29 collective bargaining unit's agreement are reduced proportionately by the amount for the  
30 collective bargaining agreement, and the corresponding funding source amounts are reduced  
31 accordingly."
