4 (g) The department **shall** [MAY] adopt regulations to carry out the purposes
5 of this section, including standards and procedures to allocate available money among
6 applications for purchases under this chapter and claims for refunds and payments
7 under AS 43.20.046, 43.20.047, or 43.20.053 when the total amount of the
8 applications for purchase and claims for refund exceed the amount of available money
9 in the fund. The regulations adopted by the department

10 (1) may not, when allocating available money in the fund under this
11 section, distinguish an application for the purchase of a credit certificate issued under
12 former AS 43.55.023(m) or a claim for a refund or payment under AS 43.20.046,
13 43.20.047, or 43.20.053;

14 **(2) must grant a preference to an applicant if at least 75 percent of**
15 **the applicant's workforce in the state in the previous calendar year was**
16 **composed of resident workers; in this paragraph, "resident worker" has the**
17 **meaning given in AS 43.40.092(b).**
