14 (e) Notwithstanding the provisions of (a) of this section, the land described in
 15 this subsection is excluded from the Palmer Hay Flats State Game Refuge established
 16 under (a) of this section for the establishment of a transportation and utility corridor.
 17 Land within the transportation and utility corridor that is determined by the
 18 commissioner of transportation and public facilities to be unnecessary for future
 19 transportation or utility corridors becomes a part of the Palmer Hay Flats State Game
 20 Refuge. The commissioner of transportation and public facilities is directed to provide
 21 access to the Palmer Hay Flats State Game Refuge during future development of state
 22 highways in the area. The land that is excluded from the Palmer Hay Flats State Game
 23 Refuge under this subsection is described as
