## FISCAL NOTE ANALYSIS

## Analysis

If enacted, HB 61 will amend AS 28.10.181 to create special motor vehicle registration plates for recipients of a Bronze Star, Silver Star, or other award for meritorious service or bravery issued by the United States military.

The Department of Administration will consult with the Department of Military and Veterans Affairs to design the new special registration plates.

**Associated costs to DMV:**

Contracted sample registration plates are \$250 per plate, per design.

According to the Department of Military and Veterans Affairs there are 32 medals that qualify as Bronze Star, Silver Star or meritorious service and bravery.

$\$250 \times 32 = \$8.0$

HB 61 takes effect January 1, 2016.
