Pursuant to adjournment the House was called to order by Speaker Chenault at 10:34 a.m.

Roll call showed 34 members present. Representative Munoz had been excused from a call of the House today. Representatives Edgmon, Thompson, and Vazquez were absent and their presence was noted later.
