## **One Hundred Second Day**

The House was called to order by Speaker Chenault at 11:03 a.m.

Roll call showed 32 members present. Representatives Hawker and Thompson had been excused from a call of the House today. Representatives Claman, Pruitt, and Wool were absent.

Representative Millett moved and asked unanimous consent that Representatives Reinbold, Saddler, and Vazquez be excused from a call of the House today. There being no objection, it was so ordered.
