He announced that the two versions of the bill, CSSB 196(FIN) version U; and HCS CSSB 196(FIN) version R would be considered in the meeting.

Senator MacKinnon MOVED to ADOPT the Senate version of the bill, version U.

Vice-Chair Edgmon OBJECTED.

A roll call vote was taken on the motion.

IN FAVOR: Hoffman, MacKinnon, Bishop
OPPOSED: Edgmon, Saddler, Kawasaki

The MOTION FAILED (3/3), therefore, version U FAILED to be ADOPTED.

Vice-Chair Edgmon MOVED to ADOPT the House version of the bill, version R.

Chair Hoffman OBJECTED

A roll call vote was taken on the motion.

IN FAVOR: Edgmon, Saddler, Kawasaki
OPPOSED: Hoffman, MacKinnon, Bishop

The MOTION FAILED (3/3), therefore, version R FAILED to be ADOPTED.

Chair Hoffman requested limited powers from the respective bodies.

Vice-Chair Edgmon MOVED to request limited powers of free conference for SB 196 on Section 3. There being NO OBJECTION, it was so ordered.

SB 196 was HEARD and HELD in committee for further consideration.
