1 Page 1, line 4 of the amendment, following "valor;":

2 Insert "relating to special request specialty organization registration plates;"

4 Page 2, following line 6 of the amendment:

5 Insert a new subsection to read:

6 "(I) Special request specialty organization plates. The department shall adopt
7 regulations to allow for the issuance of special request specialty organization
8 registration plates sponsored by an organization that is based in this state and is tax
9 exempt under 26 U.S.C. 501(c), is an Alaska chapter of a national organization that is
10 tax exempt under 26 U.S.C. 501(c), is a department of the state, or is a municipality of
11 the state. The department shall determine a common design and color for the plates
12 and provide for the placement of the artwork of the organization and a short piece of
13 descriptive text on the plate. The department may disapprove the issuance of
14 registration plates under this subsection when the requested plates duplicate an
15 existing registration. The regulations

16 (1) must provide that the entity requesting the issuance of the plates

17 (A) submit an application on a form provided by the
18 department;

19 (B) pay an application fee set by the department for issuance of
20 the new registration plates;

21 (C) submit registration fees for at least 50 motor vehicles
22 before specialty registration plates will be issued;

23 (D) may not be offensive in purpose, nature, activity, or name;

1 (E) may charge a fee for issuance of a specialty registration
2 plate in addition to any registration fees set by statute or regulation;

3 (2) must provide for a minimum number of registrations and renewals
4 of the specialty plate and for cancellation of specialty plates that do not meet that
5 minimum; the regulations must provide that before a specialty plate may be cancelled
6 the entity sponsoring the plate be given notice at least six months before the proposed
7 cancellation;

8 (3) must establish procedures for owners of vehicles to purchase
9 specialty registration plates under this subsection."

16 **** Sec. 4.** AS 28.10.421(d) is amended by adding a new paragraph to read:

17 (26) special request specialty organization plates under
18 AS 28.10.181(l)..... \$30
19 plus the fee required for that vehicle under (b), (c), (h), or (i) of this section; the \$30
20 fee required by this paragraph shall be collected only on the first issuance of and the
21 replacement of the plates; in addition, an entity sponsoring a special request specialty
22 organization plate may charge a fee on first issuance and renewal of the plates.""
