4 of revenue pay a supplemental 2016 permanent fund dividend to each eligible individual who
5 received a 2016 permanent fund dividend. The commissioner shall determine the total amount
6 of the dividend by dividing the amount appropriated by the Thirtieth Alaska State Legislature
7 from the earnings reserve account (AS 37.13.145) to the dividend fund (AS 43.23.045(a)) for
8 payment of supplemental 2016 permanent fund dividends by the number of individuals who
9 received a 2016 permanent fund dividend.

10 *** Sec. 11. ALASKA PERMANENT FUND.** The sum of \$683,234,813 is appropriated from
11 the earnings reserve account (AS 37.13.145) to the dividend fund (AS 43.23.045(a)) for the
12 payment of supplemental 2016 permanent fund dividends to eligible individuals who received
13 a 2016 permanent fund dividend."
