21       "\* **Sec. 18.** The uncodified law of the State of Alaska is amended by adding a new section to  
22 read:

23       ADVISORY VOTE. At a special election to be held on September 12, 2017, in

1 substantial compliance with the election laws of the state, including absentee voting and the  
 2 preparation, publication, and mailing of an election pamphlet under AS 15.58, the lieutenant  
 3 governor shall place before the qualified voters of the state a question advisory to the  
 4 legislature and the governor. The election pamphlet for the special election must comply with  
 5 AS 15.58.020(a)(6), including the requirement that the pamphlet contain statements that  
 6 advocate voter approval or rejection of the question. Notwithstanding AS 15.80.005 and other  
 7 laws relating to preparation of the ballot proposition, the question shall appear on the ballot in  
 8 the following form:

10 Do you approve of the passage by the Alaska State Legislature of a bill  
 11 that changes the appropriation limit, changes the deposit into the Alaska  
 12 permanent fund, changes the calculation of the permanent fund dividend, and

 14 from the earnings reserve account established under AS 37.13.145?

16 \* **Sec. 19.** The uncodified law of the State of Alaska is amended by adding a new section to  
 17 read:

18 NOTICE TO THE REVISOR OF STATUTES. The director of elections shall notify  
 19 the revisor of statutes when the results of the election have been certified under AS 15.15.450  
 20 if the advisory vote authorized in sec. 18 of this Act receives an affirmative majority vote.

21 \* **Sec. 20.** The uncodified law of the State of Alaska is amended by adding a new section to  
 22 read:

23 CONDITIONAL EFFECT. Sections 1 - 17 of this Act take effect only if the director  
 24 of elections notifies the revisor of statutes under sec. 19 of this Act that the question in the  
 25 advisory vote under sec. 18 of this Act received an affirmative majority vote.

26 \* **Sec. 21.** If, under sec. 20 of this Act, secs. 1 - 17 of this Act take effect, they take effect on  
 27 July 1 in the year following the year in which the notice is given under sec. 19 of this Act.

28 \* **Sec. 22.** Sections 17 and 18 of this Act take effect immediately under AS 01.10.070(c).

29 \* **Sec. 23.** Section 8 of this Act takes effect July 1, 2020.

30 \* **Sec. 24.** Except as provided in secs. 21 - 23 of this Act, this Act takes effect July 1, 2017."
