10 (B) **two years** [ONE YEAR] on probation if the person was
11 convicted of a crime that is not a crime

13 (ii) under (5) of this subsection;

14 (2) has completed all treatment programs required as a condition of
15 probation;

16 (3) has not been found in violation of conditions of probation by the
17 court for the period specified in (1) of this subsection;

18 (4) is currently in compliance with all conditions of probation for all of
19 the cases for which the person is on probation; and

20 (5) has not been convicted of an unclassified felony offense, a sexual
21 felony as defined in AS 12.55.185, or a crime involving domestic violence as defined
22 in AS 18.66.990."
