3 "\* **Sec. 42.** AS 33.07.030(a), enacted by sec. 117, ch. 36, SLA 2016, is amended to read:

4 (a) Pretrial services officers shall, in advance of a first appearance before a  
5 judicial officer under AS 12.30, conduct a pretrial risk assessment on the defendant  
6 using an instrument approved by the commissioner for the purpose of making a  
7 recommendation to the court concerning an appropriate pretrial release decision and  
8 conditions of release. In conducting a pretrial risk assessment and making a  
9 recommendation to the court, the pretrial services officer shall follow the decision-  
10 making process established by regulation under this chapter. In conducting the  
11 assessment, the pretrial services officer shall take into account any crimes  
12 committed by the defendant in other jurisdictions and give the crimes the same  
13 weight as if they had been committed in this state. The pretrial risk assessment shall  
14 be completed and presented to the court in a pretrial release report that contains a risk  
15 assessment rating of low, moderate, or high and a recommendation regarding release  
16 and release conditions, including a recommendation concerning a defendant's  
17 dependency on, abuse of, or addiction to alcohol or controlled substances, to the extent  
18 those factors are indicated by the offense or criminal history, before the defendant's  
19 first appearance before a judicial officer."
