8 (2) the property is a firearm or explosive;

9 (3) the property is taken from the person of another;

12 (5) the property is taken from an aircraft and the property is aircraft  
13 safety or survival equipment;

14 (6) the value of the property, adjusted for inflation as provided in  
15 AS 11.46.982, is \$250 or more but less than \$1,000 and, within the preceding year  
16 [FIVE YEARS], the person has been convicted and sentenced on two or more separate  
17 occasions in this or another jurisdiction of

18 (A) an offense under AS 11.46.120, or an offense under  
19 another law or ordinance with similar elements;

20 (B) a crime set out in this subsection or an offense under  
21 another law or ordinance with similar elements;

22 (C) an offense under AS 11.46.140(a)(1), or an offense under  
23 another law or ordinance with similar elements; or

1 (D) an offense under AS 11.46.220(c)(1) or (c)(2)(A), or an  
2 offense under another law or ordinance with similar elements; or
