A BILL

FOR AN ACT ENTITLED

1 **"An Act relating to boiler and unfired pressure vessel inspection reports and fees."**

2 **BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF ALASKA:**

3 * **Section 1.** AS 18.60.270 is amended to read:

4 **Sec. 18.60.270. Report of inspection; fee.** (a) Each company employing a
5 special inspector shall, within **15** [30] days following each inspection for certification
6 as required by AS 18.60.390 for a boiler or unfired pressure vessel, file a report of the
7 inspection with the [DEPARTMENT OF LABOR AND WORKFORCE
8 DEVELOPMENT UPON FORMS ADOPTED BY THE] department.

9 (b) In addition, a special inspector shall file with the department a report of an
10 inspection that discloses a condition dangerous to life or property in a boiler or unfired
11 pressure vessel. **The special inspector shall file the report within 15 days following**
12 **the inspection.**

13 * **Sec. 2.** AS 18.60.270 is amended by adding new subsections to read:

14 (c) A company or special inspector who files a report under this section shall
15 enter the report directly into the department's electronic inspection report system or

1 submit the report to the department on a form provided by the department. The
2 department shall charge a company or special inspector a fee of \$10 for filing a report
3 if the company or special inspector does not file the report by entering the report
4 directly into the department's electronic inspection report system.

5 (d) The department shall deposit the fees collected under (c) of this section in
6 the building safety account created under AS 44.31.025.

7 (e) In this section, "department" means the Department of Labor and
8 Workforce Development.

9 * **Sec. 3.** AS 18.60.360 is amended by adding a new subsection to read:

10 (d) In this section, "fee" does not include the filing fee charged under
11 AS 18.60.270(c).

12 * **Sec. 4.** AS 37.05.146(c)(53) is amended to read:

13 (53) receipts of fees for certain inspections deposited under
14 AS 05.20.060, AS 18.60.360, 18.60.395, 18.60.800, and AS 18.62.030 in the building
15 safety account created under AS 44.31.025, **and receipts of filing fees deposited**
16 **under AS 18.60.270(d) in the building safety account created under AS 44.31.025;**

17 * **Sec. 5.** The uncodified law of the State of Alaska is amended by adding a new section to
18 read:

19 APPLICABILITY. This Act applies to inspections begun on or after the effective date
20 of this Act.
