## FISCAL NOTE ANALYSIS

STATE OF ALASKA  
2017 LEGISLATIVE SESSION**Analysis**

This legislation adds a new chapter under AS 39.55 establishing state personnel procedures requiring background checks for state employees and contractors who's job duties require access to federal tax information in order to safeguard the confidentiality of protected federal tax information required by 26 U.S.C. 6103(p)(94).

The Department of Corrections currently requires criminal background checks on all prospective or current employees including fingerprinting under federal regulations, Title 28, Part 20 CFR. Fingerprinting is provided currently to the department at no fee, therefore there is no anticipated fiscal impact with passage of this legislation.
