FISCAL NOTE ANALYSIS

STATE OF ALASKA
2017 LEGISLATIVE SESSION

Analysis

This legislation amends statutes under AS 03 dealing with agriculture, animals, and food by adding new sections relating to the regulation, production, and transportation of industrial hemp. Specifically, it adds new sections under AS 03.05 making it a violation to transport industrial hemp without proof of registration or to produce industrial hemp with a tetrahydrocannabinol content between 0.3 percent and one percent, and adds a new paragraph under AS 03.05.100 defining "industrial hemp". The legislation also amends the definition of "marijuana" under AS 11.71.900(14) and AS 17.38.900(10) to specifically exclude industrial hemp.

The Alaska State Troopers' Statewide Drug and Alcohol Enforcement Unit (SDAEU) is responsible to interdict and seize alcohol and controlled substances that are illegally distributed throughout Alaska, including illegal marijuana grow operations.

Though troopers can issue citations for violations committed under this legislation, this would not result in a fiscal impact to the SDAEU. Therefore, a zero fiscal note is being submitted.
