## FISCAL NOTE ANALYSIS

STATE OF ALASKA  
2017 LEGISLATIVE SESSION

## Analysis

This legislation establishes procedures to safeguard the confidentiality of certain federal tax information in accordance with new Internal Revenue Service (IRS) requirements. The legislation amends AS 39 by adding a new chapter establishing state personnel procedures for state employees who access certain federal tax information which includes undergoing a state and national criminal history background check, and amends AS 12.62.400 authorizing the Department of Public Safety (DPS) to submit such fingerprints to the Federal Bureau of Investigation (FBI) for purposes of conducting the national criminal history background check.

Within DPS, the Division of Statewide Services' Criminal Records and Identification Bureau is responsible for processing and facilitating state and national criminal history background checks and may collect fees for such services under AS 12.61.160(d) and 13 AAC 68.900. These fees cover direct costs and have no net change in DPS' budget.

Passage of this legislation is not anticipated to have a fiscal impact to DPS. Therefore, a zero fiscal note is being submitted.
