FISCAL NOTE ANALYSIS

STATE OF ALASKA
2018 LEGISLATIVE SESSION

Analysis

SB112 provides access to the PDMP to any licensed practitioner who is reporting workers' compensation claims to an insurer, employer, or the Alaska Workers' Compensation Board under AS 23.30.096.

SB 112 also requires physicians, nurses, chiropractors, and dentists who prescribe a controlled substance to populate the controlled substance database under the Board of Pharmacy's Prescription Drug Monitoring Program (PDMP) opioid prescription information within two days of prescribing to an employee for a compensable injury.

Additionally, SB 112 requires prescribers and dispensers to report all of the patient's opioid or opium-based controlled substances prescribed by any provider (and additional data not available through the PDMP) to the patient's employer and the Office of Administrative Hearings within 30 days.

If the bill passes the following expenses will be incurred:

Services: \$12.7 (regulations project)

Professional licensing programs within the Division of Corporations, Business and Professional Licensing are funded by Receipt Supported Services, fund source 1156 Rcpt Svcs (DGF). Licensing fees for each occupation are set per AS 08.01.065 so the total amount of revenue collected approximately equals the occupation's actual regulatory costs.
