Analysis

Sections 8 and 9 of the bill state the self-funded plans provided to state employees under AS 39.30.091 are subject to the requirements outlined in AS 21.96.200 - 21.96.300. However, the plans offered under AS 39.30.091 do not meet the definition of "health care insurer" or "health care insurance plan" provided in those sections. Therefore, as written, the bill does not apply to and will have no impact to the state employee plan provided under AS 39.30.091.
