(3) provide an advisory committee that received a copy of a proposal under (2)(B) of this subsection sufficient time to

(A) request technical and scientific assistance and prepared testimony from the department relating to the proposal;

(B) review the proposal at a public meeting; and

(C) return its recommendations relating to the proposal to the board; and

(4) vote on the proposal at a public meeting after each advisory committee that received a copy of a proposal has had a reasonable opportunity to return its recommendations relating to the proposal, if any, to the board.

- (c) Subsection (b) of this section does not apply to  
(1) a petition filed under AS 44.62.220 for the adoption, amendment, or repeal of a regulation; or  
(2) an emergency regulation or order adopted under AS 44.62.250."

Page 1, line 4:

Delete "**Section 1**"  
Insert "**Sec. 2**"
