A legislative employee may not serve in a position that requires confirmation by the legislature. Appointments to boards by the presiding officer published in the legislative journal do not require disclosure.

An **exception** to that rule is a **gift of legal services related to legislative matters**. A person who accepts a gift of \$250 or more under the "legal services" exception must disclose receipt of the gift within 30 days.
