FISCAL NOTE ANALYSIS

STATE OF ALASKA
2019 LEGISLATIVE SESSION**Analysis**

This bill increases the number of inmates to a level that exceeds the system's capacity requiring the department to reopen the currently-shuttered Palmer Correctional Center (PCC). This requires that 12 medical staff be hired to staff the facility in the first year: 6 Nurse I/II, 1 Nurse III, 2 Health Practitioner I, 2 Mental Health II, and 1 Mental Health III. Cost for these staff are \$1,547.7.

Non-personal services inmate health care costs include contractual medical, dental and mental health services as well as medical commodities such as pharmaceuticals and medical supplies. The average cost is \$36.86 per inmate per day. This cost exists for all inmates who exceed the current system capacity. In year one there are 421.0 inmates above current capacity for a cost of \$5,661.4; in year two there are 736.6 inmates for a cost of \$9,904.2; in year three there are 769.1 inmates for a cost of \$10,342.4; in year four there are 770.4 inmates for a cost of \$10,358.7; in year five there are 778.1 inmates for a cost of \$10,463.0; and in year six there are 782.6 inmates for a cost of \$10,523.2.
