## FISCAL NOTE ANALYSIS

STATE OF ALASKA  
2019 LEGISLATIVE SESSION

**Analysis**

This bill adds a definition to statute for an electric-assisted bicycle. It adds an electric-assisted bicycle to the list of modes of transportation that do not have to be registered with the Department of Motor Vehicles. It also separates an electric-assisted bicycle from an electric personal motor vehicle. Finally, it separates an electric-assisted bicycle from a motor-driven cycle which includes motorcycle, motor scooter and motorized bicycle.

The Division of Motor Vehicles does not anticipate any financial impact from this bill and therefore submits a zero fiscal note.
