## FISCAL NOTE ANALYSIS

STATE OF ALASKA  
2020 LEGISLATIVE SESSION**Analysis**

This bill streamlines professional licensing provisions, and increases the efficiency of the Department of Commerce, Community, and Economic Development, as well as that of multiple boards overseeing professional licensing. It eliminates outdated requirements, aligns requirements with federal law, and eliminates burdensome regulation.

The bill's provisions eliminating courtesy state licensing of many professionals listed in AS 08.01.010, including non-resident geologists by regulation under AS 08.01.062, in favor of temporary licenses, will have no anticipated effect on the Department of Natural Resources, Division of Geological and Geophysical Surveys. The division has very few positions requiring a professional geologist's license as a minimum qualification, and even those are high-level, permanent positions not likely to be filled on a temporary basis.

The bill's amendment to AS 31.05.009(a)(2)(A) to eliminate the requirement that the Alaska Oil and Gas Conservation Commission's (AOGCC) geologist member must have "professional geologist" certification under AS 08.02.011, will likewise have no anticipated effect on the division, as the division has no role in certifying geologists as "professional geologists" under either current law or the law as amended by this bill.

The division submits a zero fiscal note. The bill's effects on the Division of Oil and Gas are addressed in a separate fiscal note.
